NPP YOUTH PETITION AGAINST CONSTITUENCY CHAIRMAN,
MOHAMMED FUSEINI.

The recent elections have left us with much to reflect on in the Sawla Tuna Kalba Constituency. Unfortunately, the actions of the Constituency Chairman have caused irreparable harm to our party's performance in the constituency.

His decision to campaign against the party and the parliamentary candidate in the just ended elections has not only led to a poor showing but has also created divisions among our support based within the constituency.

Some antiparty activities of the chairman are as below:

1. SALE OF JOBS AND SECURITY SLOTS.

It is a known fact that our constituency chairman has been selling slots meant for party youth in the constituency. We have evidence of slots he sold to people in Wa, Techiman and other places in the country.

2. SEIZURE AND HOARDING OF CAMPAIGN RESOURCES

It is a known fact that campaign materials such as wellington boots, weedicides, streetlights, footballs etc., for our campaign efforts at the grassroots level were in the warehouse under the control of the Constituency Chairman.

The hoarding of these materials not only goes against the values of transparency and fairness that our party upholds but also hinders our ability to effectively reach out to voters in the constituency. As you are aware, a successful campaign relies on the equitable distribution of resources and the active engagement of all party members.

We the youth in the constituency have learned that the Constituency Chairman defies the orders of the Regional Chairman to release the tricycle donated by him to the immediate past Parliamentary Candidate to assist in the D'Day operations. Also, several attempts were made by Lawyer Abu Jinapor to retrieve some campaign materials to augment our efforts and win the seat for the party in the just ended elections but yielded no result. We the youth are demanding a retrieval of the rest of the campaign materials from the constituency chairman to bring transparency and accountability.

3. UNRESOLVED DIVISION AMONG CONSTITUENCY EXECUTIVE. The Constituency Chairman has not shown interest in resolving the divisions among constituency Executive. These unresolved conflicts not only create internal strife but also weaken our collective ability to mobilize support and deliver on our party's objectives.

4. UNDER UTILIZATION OF PARTY STRUCTURES. Despite the available party structures in the constituency, the constituency chairman has regrettably failed to effectively utilize them but prefers to work with his "two wise men" own team, Constituency Organiser and Constituency Youth Organiser at the neglect of the party structures. This underutilization diminishes the impact of our organizational framework and draws back our outreach and engagement capabilities.

These issues demand immediate attention to put things in order to ensure the smooth functioning of the party in the constituency and to uphold our values of transparency, inclusivity and effective leadership.

We respectfully request that you intervene and address these concerns promptly. Our collective success especially in rebuilding process hinges heavily on cohesive and proactive leadership at all levels.

5. UNPROVOKED ATTACK ON THE IMMEDIATE PAST PARLIAMENTARY CANDIDATE AND FORCEFULLY TAKEN AWAY THE CAMPAIGN VEHICLE.

The Constituency chairman without any provocation in the company of the Constituency Organizer, Constituency Youth Organizer and the Regional deputy Nasara Coordinator **PHYSICALLY ATTACKED THE FORMER CANDIDATE ANKAARA SANKARA** AND forcefully took the campaign vehicle from him. The situation was so embarrassing that it brought the name of the party into disrepute. This is in direct contravention to article 4(7) (1) (b), (g) of the NPP constitution.

Based on this, we the Youth request a thorough investigation into this incident and appropriate disciplinary action be taken against the constituency chairman. It's worth noting that there has been instances in the past where NPP Parliamentary Candidate faced similar unfair treatment from the same Constituency Chairman.

Chairman has labeled every past parliamentary candidate as a scammer, fraudster, thieves etc. All DCEs who have served under the Chairman's tenure are neither spared with such unprintable insults and name calling.

6. ILLIGAL SUSPENSION OF EXECUTIVES

The constituency Chairman **MOHAMMED FUSEINI** is not only a bully and arrogant on NPP Executives but also demonstrate insubordination and gross disrespect towards all political leadership. He has unilaterally suspended a number of Executives including polling station and electoral area coordinators as well as sacked his Constituency Secretary. Per the letter attached, dated 10th February 2024, signed and addressed to the General Secretary under the heading **"UNFAIR TREATMENT FROM THE CONSTITUENCY CHAIRMAN TOWARDS ME"** by the Constituency Secretary, Mr. Jonathan Gilbieri Laamiitey catalogued among other things, misconduct actions taken against him by the Constituency Chairman, Mohammed Fuseini. Point 4 of the Constituency Secretary's letter clearly shows the insubordination, arrogance and gross disrespect demonstrated by the Constituency Chairman, walked out of the meeting

organised by the Regional Chairman where the Hon. Regional Minister, MMDCEs and the entire Regional Executive Committee was in attendance.

7. REGIONAL COUNCIL OF ELDERS INTERVENTION: We have also gathered information that the Regional Council of Elders upon noticing the anti-party activities being championed by the chairman, visited the constituency chairman and appealed to him to reconsider his actions against the party and work with the parliamentary candidate but it all felt in deaf ears since after the meeting we the youth noticed that he had not change his behaviour towards the party. We the youth in the constituency found the Chairman's action as unlawful. We want to emphasise that punitive action should be taken against the constituency Chairman to ensure transparency and adherence to the party's constitutional framework as stipulated in article 3(7) of the NPP constitution-amended 2017.

We respectfully request that you intervene and address these concerns promptly. Our collective success in the rebuilding, restructuring and reorganizing activities hinge heavily on cohesive and proactive leadership at all levels."

We the youth of the Sawla Tuna Kalba hereby petition for disciplinary actions against **MOHAMMEND FUSEINI**, the constituency chairman for misconduct which have been in direct conflict with the party's constitution as stipulated in Article 3(7)(1) which states that a member may be suspended from membership or office who misconducts himself/herself pending an enquiry by the disciplinary committee.

Specifically, these actions of the Constituency Chairman are in clear breach of the party's constitution and contravenes with the provisions of Article 3(5) A (2) which states that all members shall protect the unity of the party. We respectfully request that you take appropriate disciplinary actions for the betterment of our beloved party.

UNFAIR TREATMENT FROM THE CONSTITUENCY CHAIRMAN TOWARDS ME

I pray this letter finds you in good health. I write to draw your attention to the unfair treatment from my Constituency Chairman in the person of Fuseini Mohammed. I shall catalogue them in points below.

1. As you might be aware, I contested for the just ended parliamentary primaries in the orphan constituencies in the Sawla-Tuna-Kalba Constituency. I recused myself as a Constituency Secretary per the election guidelines. After the elections of which I lost, I tried to get back to my original position of secretaryship, but the constituency chairman would not want to see me as his secretary. He told me point blank that he is the constituency chairman and has the authority to do whatever that he wants so far as Sawla-Tuna-Kalba is concerned and that he has sacked me. On several occasions he referred to me as "Former secretary".
2. I proceeded to make a formal complaint to our council of elder's chairman in the person of Gbongbonduoriwura Alhaji Mark Nuhu in December 2023 at his house to appeal to the Chairman to back down from his decision and up to now, this yielded no results.
3. This issue was brought to the attention of the Savannah Regional Executives who were on a reconciliation tour to our constituency, and I am yet to get results from it.
4. There was a meeting called by the Regional Chairman at the Office of the Regional Minister, in this meeting, the Constituency Chairman stormed out of the meeting in the presence of the Regional Minister, MMDCEs Regional chairman and executives and some constituency executives, all because of my presence in the meeting.
5. The Constituency Chairman since December has refused to give me my monthly support from National.
6. The Constituency Chairman has also refused to give me and some constituency executives that he accused of not supporting his preferred candidate in the parliamentary primaries our share of the ten percent from SOCO project money of over One Hundred and Twenty Thousand Ghana cedis allocated to the constituency executives.
7. Also, when Lawyer Abu Jinapor, the Minister for Lands and Natural Resources donated rice to the various constituencies, the Chairman refused to give me my share and those

I have been directed by the constituency executive committee to write to inform you that you have been suspended from your position as an electoral area coordinator.


executives he accused of not supporting his candidate in the parliamentary primaries. He equally denied us of the rice from National Executives to the Constituency executives.

As the constitution of the party stipulates that party members should exhaust all internal dispute resolution mechanism before proceeding to court, I am therefore making the following demands from you Sir.

- a. Please investigate this issue and resolve it by instructing my constituency chairman to allow me to operate as the constituency secretary without any hindrance or obstruction.
- b. Instruct the constituency Chairman to release all monetary entitlements due me, that is my three months allowance of One thousand Ghana cedis each and also, my share from the over One hundred and twenty thousand Ghana cedis from the SOCO project. Equally instruct him to give out the rice due me from Lawyer Abu Jinapor and National Executives.
- c. Also instruct the Constituency chairman to release the share of the SOCO project funds due those executives that he accused of not supporting his candidate in the parliamentary primaries.

I hope and pray for a response of justice in getting a redress for my pleadings to engender a unity of purpose towards the **BREAK THE EIGHT** agenda by the party in our constituency and the nation at large.
